

هيئة فولبرايت هي لجنة التبادل التعليمي والثقافي بين الولايات المتحدة الأمريكية وجمهورية مصر العربية والتي تم إنشائها بمقتضى بروتوكول تعاون دولي بين الدولتين والذي تم توقيعه في ٣ نوفمبر ١٩٤٩ وذلك لإدارة وتيسير كافة شؤون برنامج للتبادل التعليمي والثقافي بين البلدين. وقد صدر القرار الجمهوري رقم ٩٠ لسنة ١٩٨٧ بشأن إنشاء هيئة فولبرايت، وتم موافقة مجلس الشعب على القرار الجمهوري بتاريخ ٢٧ أبريل ١٩٨٧، كما هو منشور بالجريدة الرسمية العدد ١٥ بتاريخ ١٤ أبريل ١٩٨٨. ويتم تمويل الهيئة من قبل وزارة الخارجية بالولايات المتحدة الأمريكية.

Fulbright Egyptian Student Program Master's Degree Grant

The program provides fully funded master's degree grants for university graduates to study in the U.S. for a maximum of two years.

All fields are eligible.

Eligibility Criteria:

- Egyptian citizenship.
- Applicants must be residing in Egypt starting from the application process and throughout the selection, placement and pre-departure processes.
- Bachelor's degree:
 - Minimum of "Good" for applicants in the humanities and social sciences.
 - Minimum of "Very Good" for applicants in the sciences.
- Proof of English Language proficiency. Applicants must submit a score report for only one of the following tests:
 - TOEFL ITP – minimum required score of 550
 - TOEFL iBT – minimum required scores of 80
 - Academic or General IELTS – minimum overall score of 6.5
 - Duolingo English Test – minimum required score of 105
 - English Proficiency Test from Egyptian Universities – minimum required score of 550
- Individuals with disabilities are encouraged to apply.
- Applicants must successfully complete all the steps of the application, assessment, and selection process and successfully finalize all required procedures.

Fulbright Egyptian Student Program MBA for University and Research Center Leadership

The program provides fully funded Master's Degree grants in Business Administration (MBA) in the U.S. for Egyptian full-time faculty members at Egyptian Universities or Research Centers who have a proven track record of leadership and commitment to developing the administrative and educational systems at their home institutions.

Eligibility Criteria:

- Egyptian citizenship.
- Applicants must be residing in Egypt starting from the application process and throughout the selection, placement and pre-departure processes.
- Applicants must be full-time faculty members at Egyptian Universities or Research Centers who hold a PhD degree in their field of specialization.
- Applicants from all disciplines are welcome to apply except those in the fields of Business Administration and its specializations.
- MBA degree holders and faculty members in the fields of Business, Management, Operations Management, Human Resource Management, Accounting, Economics, Finance and Marketing are not eligible to apply.
- Applicants must submit a letter of support from their home institution.
- Applicants must submit a justification statement that demonstrates a track record of leadership and service to their home universities or research centers and have a clear plan of how their MBA studies will be utilized following return.

Fulbright Egyptian Student Program Ph.D. Joint Supervision Grant

The program provides fully funded grants for students registered in Ph.D. programs at universities in Egypt to collect data and/or conduct research for their Ph.D. degrees under the joint supervision between a supervisor in Egypt and an American co-supervisor in the U.S. Candidates selected under this program spend up to one academic year at an American university to conduct doctoral dissertation research under the supervision of their American co-supervisor. US co-supervisors for selected candidates attend the student's Ph.D. thesis defense in Egypt (within two years following return of the student).

All fields are eligible.

Eligibility Criteria:

- Egyptian citizenship.
- Applicants must be residing in Egypt starting from the application process and throughout the selection, placement and pre-departure processes.
- Applicants must have a strong academic record.
- Applicants must be registered in a Ph.D. program at a university in Egypt.
- Applicants must find an American professor in the U.S. who is willing to host him/her and co-supervise his/her Ph.D. program for one academic year. The U.S. co-supervisor must be familiar with the applicant's field of study and Ph.D. proposal, as well as have the willingness to supervise the applicant's research in the U.S.
- Applicants must submit an invitation letter from one U.S. co-supervisor inviting the applicant to spend up to one year at the U.S. university to conduct his/her Ph.D. research and confirming that the research will be under the supervision of the identified U.S. co-supervisor. The letter must also include an evaluation of the applicant's thesis proposal, as well as describe the facilities that will be available to the applicant in the U.S. for conducting his/her research.
- Applicants must submit a letter of support from the Egyptian home institution Ph.D. supervisor which includes an evaluation of the applicant's thesis proposal and approval for the applicant to travel to the U.S. to conduct research and collect data for the Ph.D. degree under the supervision of the U.S. co-supervisor.
